### 3. RECOGNITION, AWARDS, PRESENTATIONS, PUBLIC HEARINGS

3.1 GHS Course Catalog Initial Presentation (Policy 2220) – Doug Drexler Mr. Drexler shared that planning for the 2019-2020 school year has begun. The high school is recommending one new course, as well as relatively minor modifications to six existing courses. These changes will better enable the high school to meet the continually evolving needs of students. The recommendations for 2019-2020 are not likely to require changes in staffing, space, or materials.

The proposed new course is Ceramics III. The existing courses have become popular, and there is student demand for more advanced skills in this area. The six classes with modifications are Studio Art, 2D Design, Advanced Studio Art, Concert Choir, Viking Ensemble and Physical Science. These courses will be brought back at the next meeting for possible approval.

Board comments, questions, concerns: What is the sequence for physical science? (The typical sequence for students is starting with Earth Science, then Biology, and in the past is was either Chemistry or Horticulture. We recognized there was a need for Chemistry, but there was a math barrier for some students, so it's more of a fundamental Chemistry.)

#### 3.2 2019-2020 School Calendar Draft (Policy 8210)

Dr. Barrett shared that the Calendar Committee has been meeting to look at the 2019-2020 school calendar. There is a shared understanding of what the committee needs to consider. This includes the most beneficial instructional time, neighboring districts and cooperatives, the unit district philosophy, elementary and middle school trimester structure, semester balance at Geneva High School, appropriate time for parent/teacher conferences and State requirement.

Dr. Barrett shared four drafts that are being considered. The next steps will be to get feedback from stakeholders, narrow the options, regroup with the committee, return to the Board with drafts and then formal adoption of the calendar.

Board comments, questions, concerns: Who is on the committee? (Faculty and administration.) How long has this committee been meeting? (It's been ongoing.) We knew we had an imbalance of semester days. Is this what lead to these discussions? (Yes.) It's been thirteen years that we looked at our calendars and coordinated with Mid-Valley and the Fox Valley Career Center due to students missing up to seventeen days of school because our calendars did not coordinate.

3.3 2018 Tentative Tax Levy Presentation

Dr. Romano shared the tentative tax levy with the Board. The levy process began in September, and one change this year is the adoption of a tentative levy. There are three components that we look at. They are the tax levy, cashflow and the budget. The factors that are used to determine the levy are the Equalized Assessed Value (EAV), tax rate and formula used to calculate the tax rate. The District

submits a proposed levy to the County, but in order to ensure that we do not lose revenue relating to the "tax cap" formulas, we will 'balloon' levy, or levy a larger amount than what we will receive. The proposed capped funds for 2018 would be 4.99%. However, we are estimating a tax extension increase of just 2.91%. The idea behind the 'balloon' levy is to make sure that we don't cut ourselves short with new construction funds available to the district. The District is estimating to receive a maximum of about \$2 million in new revenue with an estimated total of just over \$87.3 million. The next step in the levy process by law is for the final proposed levy to be developed and approved by the Board in December.

Board comments, questions, concerns: This highlights some of the challenges of funding the district primarily through local property taxes. What is the ten-year rolling average for the Consumer Price Index (CPI)? (1.6%) Another component that's important to highlight is that new construction is outside of this formula. We don't have a surplus. What we have is funds to start the next school year. Do you anticipate any changes to the levy before it comes back for approval? (Not really.) Could you tell us again what the 30% in reserves is for? (There's a common 'Best Practices' out there that looks for a level of reserves equal to three to four months of operation. It's important to have these funds for any emergencies that arise.) Is that 30% as of the end of the fiscal year? (Yes. When you look at cash flow, you want to look at your low and high points. For us, this is May and June.) There haven't been any short-term loans or bridge loans in the last several years.

Board members responded to the public comments with there own comments related to teacher negotiations. One Board member stated that they love Geneva teachers and that they fought for a position on the Board because of their love for Geneva schools. They wanted to be a part of making the district stronger and shaping the future generation of Geneva. Having spoken to many teachers before beginning their term, it was apparent that experiences of past negotiations left this district with a level of distrust on both sides. Being naive, they believed that their ability to collaborate, analyze and approach issues factually would help guide them through the future negotiations smoothly. It's apparent that this team, and it is a team, is broken. As adults, we should all have the skillset to departmentalize and to come to the table to focus on business. The job that they came into so proudly has made them feel more disconnected and restless than they have ever felt. The respect that we are asked to show our employees is a two-way street. This Board has the unique job of serving not only community members with children who attend our schools, but every Geneva tax payer. This Board wants this district to be competitive with surrounding districts. One that rewards for education. One that teachers continue with throughout their career. They want a financially stable district and one that is prepared for everything that comes their way while supporting the everchanging needs of our students, sustaining the jobs of our teachers and protecting the interests of our residents.

Another Board member echoed that they too love Geneva teachers. Their own children attended Geneva schools, and two of them are now teachers themselves. We know from experience that carrying a public campaign on either side leads to a negative climate, both in our community and to me, but also within our building community. This impacts district staff that have nothing to do with these negotiations, yet they will feel the effects of it regardless. They are appreciative of being a part of a Board that agrees on the issue of limiting their comments yet balances them with the need to let the community know that they are elected officials. We stand by our press releases, because they

were designed by us. We believe in our teachers. We believe in fair and equitable pay. Their sole agenda as a Board member was to come in and support the district and the community. For the record, they respect and admire everyone of their fellow Board members for their focus on children, staff and the community. This is one of the most highly functioning Boards the district has had. The Board is committed to working on a contract until it is done and acceptable by both parties.

Another Board member shared that, like their fellow Board members they have spent years volunteering their time and talent for better education for students across Illinois and specifically in Geneva. They understand and take very seriously their responsibilities of their position as an elected Board member. They work hard to represent all of their constituents. They value education and have deep respect for educators. When our teachers informed us of overcrowding, we responded by adding mobile classrooms, a cost-effective solution for our taxpayers. When we heard about higher case loads due to more social emotional issues within our student body, we responded by adding more staff and evaluating programs. When we heard rumblings that professional development wasn't as effective as it could be, we empowered our teachers to determine the best programs and betterment of their craft. When we were approached about expanding programs, such as all-day kindergarten and coursework at the high school, we responded by adding approximately 40 new teachers in the past four years. When the economy took a downward turn, we addressed our outstanding debt service to help our taxpayers, while keeping our commitment to have no reduction in force. We have kept our buildings safe and clean. We have provided much needed technology upgrades to make our students competitive in the 21st century. And, we have dealt with the chaos that comes out of Springfield all while showing a deep commitment and respect to our teachers. Despite what you may have heard, the Board and the GEA agree on more than we disagree on, and we have spent months trying to collaboratively find a way to achieve those mutual goals. We are so much better when we work together. We hope that we can continue to move forward with the best interests of all involved.

Another Board member shared that they have seen the email blasts that the GEA has been sending out. What they say is that the Board is not bargaining in good faith. This couldn't be further from the truth, and teachers should ask your leadership what we have been doing the last few days. We are probably a lot closer than anyone thinks. We are having productive conversations and meetings. We are very optimistic that we can reach an agreement.

### 6.2.6 Approval of ISBE Application for Five-year Renewal of Previously Approved Waiver: Driver Education Fee

Dr. Romano explained that the Illinois State Board of Education and the State Legislature have a program whereby school districts may apply for waiver or modification of the State Board rules and/or School Code mandates, and the hearing is one of the requirements of the application process. The required notices of the public hearing had been made as required; i.e., publish a notice on the District's website at least 14 days in advance of the hearing; publish a notice in a newspaper of general circulation at least 7 days in advance of the hearing; provide written notice 7 days in advance to the applicant's exclusive bargaining agent(s) affected by the request. Notices of a public hearing were also sent to the state legislators representing the applicant's area. The waiver application renewal sought an additional five-year approval to change the amount of the fee charged by the district to students who participate in the driver education course from "not to exceed \$50/\$250" to "not to exceed \$500", which is more reflective of the actual cost to provide the instruction. The administration recommended Board approval to submit the application for renewal of waiver or modification of State Board Rules and/or School Code Mandates regarding driver education fees, as presented.

6.3 Safe Routes to School

Dr. Romano shared that the City of Geneva has notified the District of its desire to submit an application for the 2019 Illinois Safe Routes to School Program (SRSP). This grant would provide funding for the city to make improvements that support walking and biking environments for students. To complete this process, the District is required to adopt the resolution supporting the request and the designated project being proposed.
