4.1 IASB 2015 School Governance Recognition

He often says that this is the only public office where candidates spend their own money, and get their families involved in the campaign to earn the right to volunteer. We have a redesigned banner that we are rolling out, and it symbolizes things we are doing for our students as our mission and vision.
