## 3. BOARD DIALOGUE TOPICS

# 3.1 Goal Action Planning

Board members met with administrators to review Board discussions from the previous retreat. Administrators led the retreat by asking Board members to share their thoughts from notes taken at the last retreat.

Mike Wilkes shared information on the summer tech support for the district. This year the district decided to hire students from the TSI Program at GHS. Two students applied and are now working for the district for the summer. New devices are arriving tomorrow so we are ready to go.

Dr. Barrett shared that there is plenty going on. We come to these meetings and it's a "talk at". We knew there had been several conversations about where we are going, so we wanted to get a better idea of what, you as a Board, are thinking. Collaborative presentation is where we will spend most of our time this evening. Administrators sat as a group and tried to look at the Board's ideas to see what goes together. One area is shared understandings, but the next three are where we thought we could engage the Board in conversation. The categories we will talk about are focused discussion and specific tasks, regularly scheduled communication activities and formal initiatives with stakeholders. The reflection process will consist of description, value proposition, resource investment, scope/timeframe and overall capacity score.

Board members reflected on each topic to give administrators a better understanding of what they are looking for.

Comments, questions, concerns: Do we do a course analysis on an annual basis? (Yes, it happens every year in November.) What would a tech program look like at the high school level? (It would be figuring out what they need to know ten years from now. Coding is big now, but it is about knowing what the future holds.) Does professional development make you better as an administrator? (Absolutely.) With Community Engagement, how much of this is about giving information to the community versus getting feedback from the community? (We did talk about this with the Communications Task Force. We talked about how much feedback we got on the drug workshop we offered, but it was a lot of push out and how maybe if we could have had breakout sessions after to get more feedback.) Isn't bussing a big issue when changing start times? (It's huge.) Do we want to put anything on the Board agenda about extending the elementary day? (Not at this time. We need to pull more information on this topic.)

Administrators thanked the Board members for their time this evening. They will take the matrices that were worked on tonight, put them together and get them back to the Board so that we can keep moving forward.
