Motion by Saxton, second by Cabeen, the minutes were approved as presented. 4.3 Section 7 Review (Policies 7:180 – 7:340) – Students The following policies were reviewed and are okay as they are: 7:180, 7:185, 7:200, 7:220, 7:230, 7:240, 7:250, 7:270, 7:275, 7:280, 7:285, 7:290, 7:305, 7:310, 7:315, 7:325, 7:330 and 7:340.

Comments, questions, concerns: In policy 7:185, if a student is under the age of 13, what is that considered? (Thirteen is statute, but it would be the same for all ages.) In policy 7:240, in the first paragraph, last sentence, do we do this every year? (Yes.) In policy 7:275, has this ever happened? (No.) For policy 7:290, under "Information to Staff, Parents..., Andy Barrett will be checking to see if we provide parents with this policy every year. For policy 7:325, we will look at this policy again in the spring. For policy 7:340, we had Mike Wilkes looking at #4. We said we would correlate with recordings. Let's leave it the way it is. When a student turns 18, do we get written permission from them? (Yes.)

The following policies were reviewed and have changes: Policy 7:190, under "Required Notices", in #3, shouldn't it be "against anyone" and not just a staff member? (This might be covered in another spot, but we can change it.) Under "Weapons", #1 is not all inclusive. (Let's leave it the way it is.) Under "Prohibited Student Conduct", under #3, the lettering is off. Policy 7:210, under #4 add letter e. It should say "That placement of this student in an

alternative program as an option in lieu of expulsion is in the best interest of the student." Policy 7:260, under the fourth paragraph, #1, change "He or she" to "The student" and "his or her" to the "students". In #2 under the fourth paragraph, change "He or she" to "The student". In the seventh paragraph, second sentence, change "his or her" to "their". Policy 7:300, In #6 and #7, change "his or her" to "their".
