Assistant Superintendent for Business Services Todd Latham shared that the district is asking the Board to approve the tax levy amounts in the following funds: Education Fund, \$56,100,000; O&M Fund, \$11,582,900; Transportation Fund, \$2,306,989; Municipal Retirement Fund, \$1.4 million; Social Security Fund, \$1,683,604; Fire Prevention & Safety Fund, \$1,544,000; and Special Education Fund, \$4,559,567; which totals \$79,177,060.

### 4. LEGISLATIVE UPDATES

Board Member Code of Conduct #8 - "I will be sufficiently informed about and prepared to act on the specific issues before the Board, and remain reasonable knowledgeable about the local, State, national, and global education issues." Jackie Forbes shared that last time she reported updates, the General Assembly was in veto session. They did have several bills that passed both chambers, and now await the governor's approval. There are five of them, HB594, HB1975, HB2778, SB1139, and SB1169. There was no more activity on these than usual. At the federal level, it was reported that there was the Infrastructure & Investment Jobs Act that was approved. Illinois is expected to receive about \$17 million from this act.

Going back to the IASB resolutions that were discussed at the last meeting, Ms. Forbes attended a webinar that presented additional information on the voting process. These are not laws, but the General Assembly can introduce resolutions that might become law. She inquired about abstaining and was told that IASB has no option to abstain on votes in years past. This year, there will be an app that is used to vote, but they do not know yet if abstain will be one of the options. There is new information regarding resolution #15, which is a law. What they are asking is to modify the law to say, "under 18" instead of "under 14". We did already agree on how we would vote, but, in light of the new information, she wanted to give everyone a chance to rethink their position on this resolution.

Board comments, questions, concerns: On resolution #2, we talked about our district not wanting to get in the way of other districts advocating for gun law. This resolution would not get most of our community's support, so a no vote is where we should stand. We did agree to vote no on this resolution. We should abstain, because if we were having to advocate for something for our individual district, hopefully other districts would not stand in the way of that. Gun safety is a priority, but gun control by anyone other than a police officer would be an error. On resolution #15, it felt as though not everyone knew this was a law looking to be extended. We had voted to not adopt this resolution at the last meeting. We should support a yes vote on resolution #15. It sounds like you are saying to vote yes on resolution #15 and no on resolution #2. It looks as though the majority want to vote no on resolution #15.

### 5. SUPERINTENDENT'S REPORT (Policy 3:40)

The Superintendent thanked the Board members for attending the recent PTO meetings. Attending these meetings gives the Board and administration the opportunity to thank the PTO board members for their hard work. PTO members do a great deal of volunteer work to help our students. As a reminder, there is no school for students next week. Monday and Tuesday are parent/teacher conferences that are in a blended format. Some are in-person, and some are virtual, depending on the parent's choice. We resume school following Thanksgiving on November 29<sup>th</sup>.
