Student Services Programming at Geneva High School - Anne Scalia 2. Director of Student Services Anne Scalia shared information about the student services programming at Geneva High School. The district currently has 702 students that qualify for special education services. Of those 702, 560 receive specialized instruction, such as social work, speech, occupational therapy, physical therapy, hearing itinerant services, and vision services. The majority of our special education students receive services within the regular classroom. In the fall of 2021, 200 students will qualify for special education services at Geneva High School with 70% receiving specialized instruction within the general education classroom and 30% receiving specialized instruction in a selfcontained program. The programs and services provided require staff to co-teach in many subject areas. The benefits to co-teaching are tiered levels of instruction, differentiated instruction, increase in student engagement, variety of instructional strategies, increased opportunities for response and participation, and formative assessments. Most special educators are coming to understand that specially designed instruction (SDI) is imperative in co-teaching. It is being proposed that the district provide professional development (PD) for co-teaching using IDEA grant funds. Marilyn Friend is a well-known public speaker that provides PD in co-teaching. This PD will allow improved student outcomes and teacher retention.

Board comments, questions, concerns: The 200 students for the fall of 2021, is that an increase from 2020? (It is about the same.) Are there any metrics in terms of success or how it could be measured? (Some success will be by teachers giving their self-assessment, reflection, and rating scales on some of the things they have been doing. We always want to see our overall test scores go up and, of course, see our student's IEP goals met.) The budget that is being proposed tonight for this professional development, is that coming from grant funds? (Yes, it will come from our IDEA grant funds, which requires us to use 5% of the funds for PD.) When you used the example of a chemistry teacher in the gen ed group, is it going to be gen ed teachers in the same department or are you pulling from everywhere? (It will be the co-teacher and their pair.)

#### 5. PUBLIC COMMENTS

Parents shared their concerns regarding racial bullying within the district. One parent has three students in the district who are bi-racial and have been bullied during their years in Geneva. To say that these things do not happen in Geneva is beyond ridiculous. The last two years have been extremely hard for her two elementary children who have been told to "go wash their dirty brown skin", "I'm not allowed to play with black people", had their hair pulled, been pushed into walls, and excluded from groups. She had to pull her children from the bus for their safety while the bully continued to get free rides with no consequences. Her daughter loves online learning, because no one can bully her. It is easy as a privileged white person for you to deny and sweep things under the rug. What are the districts plans to address these issues in the future to ensure that all our children feel safe in school?

Another parent shared that bullying continues to be a concern. Students that come forward have done so with much consideration, which is why it is imperative to take these allegations seriously. Not doing so puts the complainant in a precarious position. It is our responsibility to ensure our children are taught social emotional skills making them good citizens. If we fail them on this front, then we are missing a key component in their development. What plans does the district have to teach our children non-bias, and how can we take control of a completely lucid space for students?

As we enter the last few weeks of the school year, one parent shared her concerns about the critical time we are in with the pandemic. Vaccines are readily available, but only to those over the age of 16. New, more contagious variants are circulating, particularly with those under the age of 20. Hospitalizations are also on the rise with this younger group. The more active the virus is within our community, the more possibility it has to mutate into new variants. We need to maximize our mitigation strategies, particularly at the high school and middle school levels. The additions to the COVID dashboard are appreciated but updating more frequently would further improve transparency. Another mitigation strategy to consider is saliva testing. Other districts are using this form of testing and the Cares Act can be used to fund this.

The Board President shared that there will be a presentation on May 10<sup>th</sup> to review the diversity, inclusion and anti-bullying practices in the district. There will also be discussion on where we are and where we are going. There has been communication with the City of Geneva, and they have a task force they are forming, which we have asked to have a liaison on. It is important that we work with the city as a team on this topic.

## 6. LEGISLATIVE UPDATES

Board Member Code of Conduct #8 - "I will be sufficiently informed about and prepared to act on the specific issues before the Board, and remain reasonable knowledgeable about the local, State, national, and global education issues." The legislation has many ideas coming out this year, however nothing is finalized. We are worried about the unfunded mandates and how those ideas might impact students.

The Superintendent thanked Dave Lamb and Leslie Juby for their many years of service on the Board, and he congratulated the re-elected Board members, as well as the newly elected Board members.

1. Board Action on the 2021-2022 Student Fees (Policy 4:140)

Assistant Superintendent for Business Services Dr. Dean Romano shared that student fees were discussed at the most recent finance committee meeting. The most notable change to next year's fees is the technology fees for K-5. There will also be unique fees at individual buildings, such as roller skating and assignment notebooks.

Dr. Romano gave a brief overview for the new Board members on how the Capital Projects Fund came to be. There may be a need to do another transfer of funds in June.

Dr. Romano shared that there have been conversations with both the finance committee and the Board about the preliminary budget for transportation. It was identified that there was an opportunity to bring all transportation back in-house, which the district has been working toward for many years.

To do this, we will need to purchase additional vehicles for the specialized needs of students. The total cost for this purchase would be \$584,875.
