Jackie Forbes shared that SB2101 still has not been signed. SB0654 that requires 20 minutes of play

time for K-5 students is still waiting on the governor. HB4, which is a bill that would allow for elearning if a school is a polling place is still waiting on a signature as well.

The Superintendent shared that new teachers are in this week, and they kicked the week off with a lunch provided by the Joint PTO. This is a great show for our new staff of the support of our community for education. Our buses and drivers are getting ready for the first day of school. All staff return on Monday, August 16, with students returning on Tuesday, August 18.

#### BOARD DIALOGUE TOPICS & PENDING ACTION CONSIDERATION

2021-2022 School Year Plan

Dr. Andy Barrett and Shonette Sims provided the Board with an update on the 2021-2022 School Year Plan. The main goal of this plan is to provide full in-person learning for all students PK-12<sup>th</sup> grade. This plan covers three main topics: masking, contact tracing & quarantining, and testing. The governor just announced an executive order that requires masks be worn by all staff, students, and visitors at all school buildings regardless of vaccination status. This applies to anyone riding a bus as well. Based on current close contact guidance, quarantine will be drastically reduced if all individuals are masked. The district will begin the school year by following the Governor's executive order. As guidance changes, the district will remain focused on transitioning to a pre-pandemic learning environment. Staff, students, and visitors that do not comply with the masking requirement will not be allowed to enter the building. Students who are absent due to a positive COVID-19 test, will have instructional supports. At the last meeting, there were questions regarding the Shield Testing, and after more research, the district does not recommend a testing program at this time. Families seeking a COVID test should contact their local medical provider, local testing sites, VNA, or IDPH testing sites. The district will continue the Situational Monitoring Approach when determining if additional mitigation strategies should be increased or decreased.

Board comments, questions, concerns: I understand that if the numbers go down, that we would begin to remove mitigation levels, but what mitigations might be added if the numbers go up? (There would be enhanced cleaning and distancing. We would have the capacity to layer in more mitigations.) How would it be handled if a student will not wear a mask? (Everyone must wear a mask, and we have layered mitigations to address this. Students need to be in school, and we hope we do not have to use these mitigations.)
