The Board of Education Policy Committee met at 6:15 p.m. on Monday, January 24, 2022, at Geneva Middle School South, 1415 Viking Drive, Geneva, Illinois.

### 1. CALL TO ORDER

The meeting was called to order at 6:15 p.m. by Committee Chair Saxton.

  - In section 8, is there any insight into the changes for (a) and (b)? (The language changes do not represent any changes in our practice.) I presume the struck-out language in (b) will not have any impact? (Correct.) For required question 1, do we want to say yes or no? (It would be no with the long explanation after it.) For required question 2, it would be recommended that we use the fifth choice that states the Board either does not offer NSES, or offers NSES but does not want to communicate that in this policy, etc. The State has put out information on sex education standards and is supposed to develop its own by August. We have always had a comprehensive health education program and it meets all the applicable requirements. For question 3, we would recommend no. This is a subject we address in a wide variety of courses. You noted that this topic would be in several classes, but do you have an approximate number of how many of our high schoolers would have exposure to this? (It is addressed in U.S. History, Government, and other social studies courses.) It sounds like what you are saying, is that some may have a deeper involvement in the material because elective courses may cover this? (Correct.)

We do not know what the State will or will not consider as the next most rigorous course. We have many questions as well.) What is the district vision or plan to attract unrepresented groups? (One of our goals is that a student can enroll in any class and be successful. There are many ways to reach out to students and parents.)

While the language itself is appropriate, I would be concerned about discretion. For required question 1, are you wanting us to say yes so that it is more encompassing? (Yes, that would make it more helpful.) We would recommend no, because it speaks to it above, and if you look at the legal citation, we must be careful with this one. It is very ambiguous as to what a disruption could be. Is there any history of this? (No.) Do you as administrators have any concerns if we go with the revised language? (No.) We will answer yes for guestion 3.

(I would go with Dr. Mutchler's recommendation, but you could also table this one and come back to it once more conversations have taken place.) We are going to table this one and come back to it at a future meeting. Questions 2 and 3 will also be tabled.
